

Providers: Update NPPES Taxonomy

On **May 20, 2019** Express Scripts will be implementing additional enhanced prescriptive authority logic for prescribers of CHPW Medicare and Medicaid patients. This additional logic will validate the prescriber has the appropriate authority to prescribe controlled substances, based on WA state prescriptive authority rules and the prescriber's taxonomy in the **National Plan and Provider Enumeration System (NPPES)**. Prescriptions will reject if the prescriber does not meet criteria determine by WA state law. An override will be made available if the pharmacist has validated the prescriber has prescriptive authority.

All the applicable taxonomy codes based on the National Uniform Claim Committee will be grouped within the following license types for the state prescriptive authority validation:

- Clinical Nurse Specialist (CNS)
- Medical Psychologist (MP)
- Naturopathic Doctor (ND)
- Nurse Midwife (NM)
- Nurse Practitioner (NP)
- Doctor of Optometry (OD)
- Physician Assistant (PA)
- Pharmacist (RPh)

Did you know Arcadia is a powerful data integration tool to help clinics support Quality Improvement, Revenue Improvement, and Cost Management?

Did you know Arcadia can be used to generate medication reports such as:

- Examining Harmful Drug-Drug Interactions
- Filtering and Identifying Population Specific Medication Management Opportunities such as Antidepressant Adherence in Spanish Speak Patients
- Tracking Unfilled Prescriptions

Did you know it is easy to obtain an Arcadia user account if you do not have one? You will need to request access to Arcadia through your Clinic's IT Administrator. You will first need One Health Port Access which is also set up by your site administrator.

Updates Planned for AMM IPSD Report

Updates are coming soon to the **Antidepressant Medication Management (AMM) Index Prescription Start Date (IPSD) Report** to help prioritize outreach and make this report more actionable. The aim of this report aligns with a **HEDIS measure** to improve adherence and persistence to newly treated adults on antidepressant medications. To incorporate feedback from the Pharmacy Director's Roundtable, the following updates will be implemented:

- Distinguish CHC vs outside providers
- Identify depression related diagnoses
- Prioritize cases according to provider and most relevant antidepressants

These changes will be incorporated into our upcoming report, scheduled for the week of March 25th, 2019.
